5 A RESOLUTION OF THE CITY OF SOUTH FULTON ESTABLISHING
6 A DEADLINE FOR THE FIRST DRAFT OF THE CITY STRATEGIC PLAN AND FOR
7 OTHER LAWFUL PURPOSES

11 WHEREAS, the City of South Fulton ("City") is a municipal corporation duly
12 organized and existing under the laws of the State of Georgia;

13
14 WHEREAS, the duly elected governing authority of the City is the Mayor and City
15 Council ("City Council");

16
17 WHEREAS, pursuant to City Resolution 2018-013, "the City Manager shall
18 annually develop and bring to the City Council an update of a City-wide strategic plan
["Strategic Plan"];

19
20 WHEREAS, a Strategic Plan is significant in helping the City Council to establish
21 long-term City goals, set key performance measures for each goal and address City
Council strategic priorities.";

23 WHEREAS, the City Council desires to set deadline for the City Manager to bring
a Strategic Plan before the City Council; and

25 WHEREAS, this Resolution is in the best interests of the general welfare of the
City, its residents and general public.

27 NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL as
follows:

29 Section 1. The City Manager is hereby directed to bring to the City Council a final
30 proposed Strategic Plan for consideration and review no later than the City Council's first
31 Council Workshop on July 9, 2019.

34 Section 2. It is hereby declared to be the intention of the Mayor and Council that: (a)
35 All sections, paragraphs, sentences, clauses and phrases of this Resolution are or were,
36 upon their enactment, believed by the City Council to be fully valid, enforceable and
constitutional.

38 (b) To the greatest extent allowed by law, each and every section, paragraph, sentence,
39 clause or phrase of this Resolution is severable from every other section, paragraph,
sentence, clause or phrase of this Resolution. No section, paragraph, sentence, clause

40 or phrase of this Resolution is mutually dependent upon any other section, paragraph,
41 sentence, clause or phrase of this Resolution.

42 (c) In the event that any phrase, clause, sentence, paragraph or section of this Resolution
43 shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise
44 unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is
45 the express intent of the City Council that such invalidity, unconstitutionality or
46 unenforceability shall, to the greatest extent allowed by law, not render invalid,
47 unconstitutional or otherwise unenforceable any of the remaining phrases, clauses,
48 sentences, paragraphs or sections of the Resolution.

49 **Section 3.** All Resolutions and parts of Resolutions in conflict herewith are hereby
50 expressly repealed.

51 **Section 4.** The effective date of this Resolution shall be the date of adoption unless
52 provided otherwise by the City Charter or state and/or federal law.
