

**AN RESOLUTION TO AUTHORIZE & SELECT THE GEORGIA GENERAL  
ASSEMBLY REAPPORTIONMENT OFFICE TO REDRAW THE CITY OF SOUTH  
FULTON'S REDISTRICTING MAP**

**(Sponsored by Mayor khalid)**

**WHEREAS**, the City of South Fulton ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia; and

**WHEREAS**, the duly elected governing authority of the City is the Mayor and City Council thereof ("City Council"); and

**WHEREAS**, the full and complete legislative and policy making authority of the City resides in the part-time city council; and

**WHEREAS**, pursuant to City Charter Section 3.10 (b), the City Council is authorized to adopt ordinances and amendments it deems necessary, expedient, or helpful for the health, welfare, safety, comfort and well-being of the inhabitants of the City; and

**WHEREAS**, the Reapportionment Office of the General Assembly are the leading technical experts in this field and offers a redistricting service to all Georgia municipalities at no charge,

**THE CITY COUNCIL OF THE CITY OF SOUTH FULTON HEREBY  
RESOVLVES** as follows:

**Section 1.** The City of South Fulton shall continue to use its current District Map for any Special Election(s) held before December 31, 2022.

**Section 3.** All Resolutions in conflict herewith are hereby expressly repealed.

**Section 4.** The City Attorney, City Clerk and contracted City Codifier are authorized to make non-substantive formatting and renumbering edits to this ordinance for proofing, codification, and supplementation purposes. The final version of all ordinances shall be filed with the clerk.

**Section 5.** The effective date of this Ordinance shall be March 22, 2022.

The foregoing RESOLUTION No. 2022-019, adopted on March 22, 2022 was offered by Councilmember Sebastian, who moved its approval. The motion was seconded by Councilmember Gumbs, and being put to a vote, the result was as follows:

## MAYOR'S SIGNATURE PAGE

The mayor, within ten (10) business days following receipt of an ordinance, resolution, or other action adopted by the city council shall return it to the city clerk with or without the mayor's approval or with the mayor's veto. If an ordinance, resolution, or other action adopted by the city council has been approved by the mayor or if it is returned to the city clerk neither approved nor disapproved, it shall become law upon its return to the city clerk. However, if the mayor fails to return an ordinance, resolution, or other action adopted by the city council to the city clerk within ten (10) business days of receipt, it shall become law at 12:00 Midnight on the tenth business day after receipt. If the ordinance, resolution, or other action adopted by the city council is vetoed by the mayor, the mayor shall submit to city council, through the city clerk, the reasons for the mayor's veto. The city clerk shall record upon the ordinance the date of its delivery to and its receipt from the mayor.
