5 A RESOLUTION BY THE CITY OF SOUTH FULTON, GEORGIA, AUTHORIZING AN
6 AGREEMENT WITH LADAWN JONES TO SERVE AS THE CITY'S INTERIM COURT
7 ADMINISTRATOR FOR MUNICIPAL COURT OF THE CITY OF SOUTH FULTON
8 AND FOR OTHER LAWFUL PURPOSES

10 WHEREAS, the City of South Fulton ("City") is a municipal corporation duly
11 organized and existing under the laws of the State of Georgia;

12
13 WHEREAS, the duly elected governing authority of the City, is the Mayor and
14 Council thereof ("City Council");

15
16 WHEREAS, the City Council desires through this Resolution to authorize an
17 Agreement for attorney LaDawn Jones to serve as the Interim Court Administrator for the
18 City Municipal Court; and

20 WHEREAS, this Resolution is in the best interests of the health and general
21 welfare of the City, its residents and general public.

23 THE COUNCIL OF THE CITY OF SOUTH FULTON, GEORGIA, HEREBY RESOLVES
24 as follows:

26 **Section 1.** The Mayor, City Manager, Human Resources Director and City Attorney are
27 hereby authorized to negotiate, draft and/or enter into an agreement with LaDawn Jones,
28 as Interim Court Administrator, for the City Municipal Court with the term of the Agreement
29 beginning on or about May 1, 2021 and ending on December 31, 2021 and for the
30 commensurate and appropriate amount of compensation for the position, job duties and
31 title of Interim Court Administrator.

33 **Section 2.** It is hereby declared to be the intention of the City Council that: (a) All sections,
34 paragraphs, sentences, clauses and phrases of this Resolution are or were, upon their
35 enactment, believed by the City Council to be fully valid, enforceable and constitutional.

36
37 (b) To the greatest extent allowed by law, each and every section, paragraph, sentence,
38 clause or phrase of this Resolution is severable from every other section, paragraph,
39 sentence, clause or phrase of this Resolution. No section, paragraph, sentence, clause
40 or phrase of this Resolution is mutually dependent upon any other section, paragraph,
41 sentence, clause or phrase of this Resolution.

43 (c) In the event that any phrase, clause, sentence, paragraph or section of this Resolution
44 shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise
45 unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is
46 the express intent of the City Council that such invalidity, unconstitutionality or

47 unenforceability shall, to the greatest extent allowed by law, not render invalid,
48 unconstitutional or otherwise unenforceable any of the remaining phrases, clauses,
49 sentences, paragraphs or sections of the Resolution.

50
51 **Section 3.** The City Attorney and City Clerk are authorized to make non-substantive
52 editing and renumbering revisions to this Resolution for proofing and renumbering
53 purposes. The final version of all resolutions shall be filed with the City Clerk.

54
55 **Section 4.** The effective date of this Resolution shall be the date of adoption, unless
56 provided otherwise by the City Charter or state and/or federal law.


