7 **A RESOLUTION PROMOTING A CLEANER AND GREENER SOUTH FULTON;
8 ESTABLISHING AN ADOPT-A-ROAD PROGRAM AND FOR OTHER LAWFUL
9 PURPOSES**

10 **(Sponsored by Councilpersons Gumbs and Willis)**

11 **WHEREAS**, the City of South Fulton ("City") is a municipal corporation duly
12 organized and existing under the laws of the State of Georgia;

13
14 **WHEREAS**, the duly elected governing authority of the City is the Mayor and City
15 Council ("City Council");

16
17 **WHEREAS**, the City Council is vested in providing a cleaner and greener
18 environment for City residents and visitors;

19
20 **WHEREAS**, Adopt-a-Road programs offer unique opportunities for community
21 volunteers to enhance the City's goal in ensuring a clean and green roadway system with
22 the City;

23
24 **WHEREAS**, Adopt-a-Road programs add civic pride to the community, serve as
25 reminders not to litter and save tax-payers money; and

26
27 **WHEREAS**, this Resolution and the adoption of an Adopt-a Road program within
28 the City is in the best interests of the health and general welfare of the City, its residents
29 and general public.

31 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL** as
32 follows:

34 **Section 1.** The City Council hereby adopts the "Adopt-a-Road Program" and
35 supporting documentation attached hereto as Exhibit A. The Public Works Director is
36 hereby authorized to make changes to the program, within the allocated City budget and
37 based upon the changing needs of the City, subject to review and approval by the City
38 Manager and City Attorney.

40 **Section 2.** It is hereby declared to be the intention of the City Council that: (a) All
41 sections, paragraphs, sentences, clauses and phrases of this Resolution are or were,
42 upon their enactment, believed by the City Council to be fully valid, enforceable and
43 constitutional.

44 (b) To the greatest extent allowed by law, each and every section, paragraph, sentence,
45 clause or phrase of this Resolution is severable from every other section, paragraph,
46 sentence, clause or phrase of this Resolution. No section, paragraph, sentence, clause
47 or phrase of this Resolution is mutually dependent upon any other section, paragraph,
48 sentence, clause or phrase of this Resolution.

49 (c) In the event that any phrase, clause, sentence, paragraph or section of this Resolution
50 shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise
51 unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is
52 the express intent of the City Council that such invalidity, unconstitutionality or
53 unenforceability shall, to the greatest extent allowed by law, not render invalid,
54 unconstitutional or otherwise unenforceable any of the remaining phrases, clauses,
55 sentences, paragraphs or sections of the Resolution.

56 **Section 3.** All Resolutions and parts of Resolutions in conflict herewith are hereby
57 expressly repealed.

58 **Section 4.** The effective date of this Resolution shall be the date of adoption unless
59 provided otherwise by the City Charter or state and/or federal law.


