**REGULAR MEETING MINUTES**

The meeting was called to order by Chairman Baker at 6:00 PM.

The roll call was conducted. A quorum was established.

A motion was made by Director Grooms and seconded by Director Ivey to approve the agenda with a friendly amendment to add an item to the agenda considering officer appointments pursuant to the Authority Bylaws. The amended motion was approved unanimously.

A motion was made by Director Miller and seconded by Director Pierson to approve the minutes for the September 28, 2020 Regular Meeting and October 2, 2020 Special Called Meeting. The motion was approved unanimously.

Bond Inducement Application: Comprehensive Health Medical Center  
Dr. Paul McKoy and Carina Gibbs discussed the services proposed for the 27,000 square foot multi-disciplinary medical facility located at Big Foot Trail and Old National Highway, which recently broke ground on October 2, 2020. A brief question and answer period followed the presentation.

Executive Session

A motion was made by Director Grooms to recess for an executive session to discuss Real Estate at 6:14 PM. Director Miller seconded the motion. The motion was approved unanimously.

Director Grooms made a motion to close the executive session and reconvene the meeting at 7:08 PM. Director Miller seconded the motion. The motion was approved unanimously.

Director Pierson made a motion to authorize bond counsel Doug Selby and Attorney Walker to proceed with final bond documentation on the bond application submitted by Comprehensive Health Medical Center at the next meeting should the developer wish to move forward. Director Grooms seconded the motion. The motion was approved 6-1-1.

Discussion: Consideration of Officer Appointments for the South Fulton Development Authority  
Director Grooms made a motion to reappoint the current officers to the same positions for another term. Director Jiggetts seconded the motion. The motion was approved unanimously.

Director Grooms made a motion to adjourn the meeting at 7:20 PM. The motion was seconded by Director Miller. Director Jiggetts requested that the Authority and each individual Director assess the role of the Development Authority and how it can be impactful to the community.
